#### **Bursary Report**

Report for Academic Year 2020.

#### ASSALAMUALAIKUM.

We make dua that the All Mighty Allah Tallah gives the Ummah the fortitude and wisdom to weather the ravaging scourge that is sweeping all over the world. The Ummah is being decimated by the Covird19 Pandemic and we have lost so many members of our community. This pandemic makes non distinction between gender or age.

The year 2020 will be etched in our memory as a year when the all that we had previously taken for granted has been turned into a nightmare. The devastation will be felt for many years into the future. The disruption to our educational systems at both schools and tertiary institutions will impact on our youth for several years. Hopes and dreams that parents have for their children have been destroyed.

The Bursary Committee has had to take a more practical and prudent view on the allocation of the loans. It was evident that the drastic decline in income because of the lockdown has had a devastating effect on the income of families and the Madressa. Economic projections are gloomy for income in the future.

An allocation of 41 loans were made during 2020. The applicants are enrolled in a very diverse set of programmes which reflect the concern of the community on the future employment opportunities and the need to complete the courses in as short a time as possible. The choice of programmes also reflect the availability of admission to courses and institutions. The annual increase in fees linked to the government scholarship fund NSFAS does not adequately address the need of those families deemed to in the middle spectrum of income category.

There were no applicants for Medicine and Dentistry. There were applicants who are registered in the Allied Health Disciplines. The number of students doing an educational degree, accounting, commerce and a full range of BSc dominates the choice of courses. There were three applicants in Islamic courses. The increase in enrolments at Unisa reflects the need to study part time and it is likely that this will increase dramatically because of the disruptions at tertiary institutions the cost of tuition and decline in income.

The disruption in the school programme and Matriculation will also gave a direct impact on applications at all tertiary institutions. The Bursary Committee approved the proposal to hold a Open Careers day scheduled for the end of January 2021. This was cancelled because of the rise in Covid19 infections and your risk that this posed. The Board of Management debated the perennial issue of the criteria for the allocation of loans. The debate centres around the issue of setting a financial threshold for those eligible for loan proving financial need and applicants who have adequate financial resources. As income to the Madrassah



is under stress because of lockdown and no new sources of income this debate will dominate all budgets including Welfare Grant's.

In these times of uncertainty there is a need for the Madrassa to remain focused on its original and primary goal to provide for the needy in the community.

The time for innovative solutions and a renewed commitment for the future.

The Bursary Committee is totally reliant on Mr Abdul Hak Kaka and Ms Khadija Tilly for the extensive service they provide in managing all the applications and detailed records of the entire portfolio. We thank them for their consistent hard work.

#### Opinion

#### Trustees' Responsibilities and Approval

To enable the trustees to meet these responsibilities, the trustees set standards for internal control aimed at reducing the risk of error or loss in a cost effective manner. The standards include the proper delegation of responsibilities within a clearly defined framework, effective accounting procedures and adequate segregation of duties to ensure an acceptable level of risk. These controls are monitored throughout the trust and all trustees are required to maintain the highest ethical standards in ensuring the trust's business is conducted in a manner that in all reasonable circumstances is above reproach.

The focus of risk management in the trust is on identifying, assessing, managing and monitoring all known forms of risk across the trust. While operating risk cannot be fully eliminated, the trust endeavours to minimise it by ensuring that appropriate infrastructure, controls, systems and ethical behaviour are applied and managed within predetermined procedures and constraints.

The trustees are of the opinion, based on the information and explanations given by the trustees that the system of internal control provides reasonable assurance that the financial records may be relied on for the preparation of the annual financial statements. However, any system of internal financial control can provide only reasonable, and not absolute, assurance against material misstatement or loss. The going-concern basis has been adopted in preparing the financial statements. Based on forecasts and available cash resources, the trustees have no reason to believe that the trust will not be a going concern in the foreseeable future. The financial statements support the viability of the trust.

The financial statements have been audited by the independent auditing firm, Audit Associates, who have been given unrestricted access to all financial records and related data, including minutes of all meetings. The trustees believe that all representations made to the independent auditor during the audit were valid and appropriate. #### **Accounting Policies**

#### 1. General information

Madressa Anjuman Islamia of Kholvad Education and Welfare Trust is a non-profit organisation.

#### 2. Summary of significant accounting policies

These financial statements have been prepared in accordance with the International Financial Reporting Standards for Small and Medium-sized Entities issued by the International Accounting Standards Board. The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

These financial statements have been prepared under the historical cost convention and are presented in South African Rands.

#### 2.1 Revenue recognition

Revenue comprises of donations received from Zakaat and Lillah funds.

#### 2.2 Income taxes

The association has been approved as a public benefit organisation in terms of section 30 of the Income Tax Act, (the Act) and the receipts and accruals are exempt from income tax in terms of section 10(1)(cN) of the Act.

The public benefit organisation has been approved for purposes of section 18A(1)(a) of the Act and donations to the organisation will be tax deductible in the hands of the donors in terms of and subject to the limitations prescribed in section 18A of the Act

#### 2.3 Cash and cash equivalents

Cash and cash equivalents includes cash on hand, demand deposits and other short-term highly liquid investments with original maturities of three months or less. Bank overdrafts are shown in current liabilities on the statement of financial position.

#### 2.4 Trade payables

Trade payables are recognised initially at the transaction price and subsequently measured at amortised cost using the effective interest rate method.
